**Rates: (Rental must be paid in advance)**

Dade County Sports Complex can be rented as follows:

Individual Fields: \$25.00 per day

The Dade County Sports Complex is available for rental:

Every day (including holidays) 7:00 AM – 12:00 Midnight

NO game shall be scheduled to start after 9:00 PM

**Cancellation due to weather will be made by a league representative and the sports complex supervisor.**

**Guidelines/Responsibilities:**

Person/persons renting the Dade County Sports Complex:

*You must be 21 years of age or older to rent the Dade County Sports Complex.*

**MUST** have liability insurance to cover **ALL** players with minimum coverage of \$100,000 per person. Proof must be provided.

Scorekeepers will be furnished by the Tournament Director.

All vendors must be approved by the Department of Parks and Recreation. The renters will be responsible for lining up vendors. Provided, however, Dade County shall have the first opportunity to operate concessions.

Cancellation of Tournament: **NO** penalty will be incurred by the renter **IF** the Recreation Department is notified at least seven (7) days prior to tournament starting date. **IF** notified less than seven (7) days, there will be a \$100.00 penalty.

**GAMBLING** of any form or any other illegal activity is not permitted.

Absolutely **NO ALCOHOLIC BEVERAGES** are permitted in or around the Complex.

Renter(s) further agree(s) to defend, indemnify, and hold harmless Dade County, Georgia, its officers, agents and assigns, for any injury, property damage or loss and/or death caused by or resulting from the use of the Sports Complex (including parking lots), whether or not such injury, property damage or loss and/or death was caused by or resulting from the negligence of the parties named herein (or their agents) or any other cause.

**INDIVIDUALS ABUSING THE FACILITIES ARE SUBJECT TO LOSS OF ANY FUTURE RENTAL PRIVILEGES.**
