



## DADE COUNTY COMMENDS LAW ENFORCEMENT FOLLOWING ARRESTS IN ONGOING ANIMAL CRUELTY INVESTIGATION

Dade County Government extends its appreciation to local and state law enforcement agencies for their continued dedication in the investigation of a recent animal cruelty case.

On the evening of July 9, deputies from the Dade County Sheriff's Office executed arrest warrants at a residence on Sells Lane in connection with the ongoing investigation led by the Georgia Department of Agriculture. Two individuals, Nathaniel Levon Curington (age 44) and Aimee Renee Curington (age 45), both of Trenton, Georgia, were arrested without incident and charged with seven counts each of felony animal cruelty (O.C.G.A. § 16-12-4).

While this case falls under the jurisdiction of the City of Trenton, Dade County commends the City of Trenton Police Department and the Dade County Sheriff's Office for their professionalism and unified response. The County also recognizes the Georgia Department of Agriculture's leadership as the primary investigative agency.

"Dade County stands firmly behind our law enforcement partners and has full faith in the judicial process to address these serious charges with diligence and fairness," said County Executive Don Townsend. "This case has deeply impacted our community, and we are committed to supporting accountability, transparency, and compassion every step of the way."
